SECTION 5: Firefighting measures

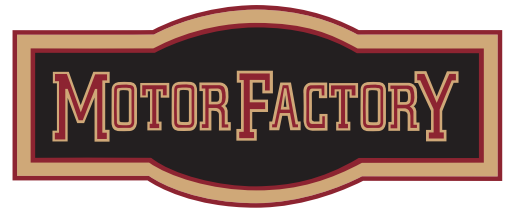
